**RESOLUTION APPROVING THE ADDENDUM TO THE MITIGATED NEGATIVE
DECLARATION PREPARED FOR THE ARSENIC MITIGATION,
PROPOSITION 84 PROJECT**

WHEREAS, the proposed project is located within the County of Kern, State of California; and

WHEREAS, the proposed project consists of mitigating the Arsenic contamination in the District water supply, including, securing funds from the California Division of Drinking Water and the findings made in the previously approved 2014 IS/MND have not changed and the mitigations identified in the IS/MND and MMRP are still in effect; and

WHEREAS, the provisions of the California Environmental Quality Act of 1970 apply to the proposed project; and

WHEREAS, an initial study of the proposed project has been conducted so as to evaluate the potential for adverse environmental impact; and

WHEREAS, notice of the opportunity to comment on the Initial Study and proposed Negative Declaration was provided as required by law; and

WHEREAS, after considering the record as a whole and proposed mitigation measures, it has been determined there is no evidence that the proposed project will have significant affect on the environment, nor will it have any potential to adversely affect wildlife resources or the habitat upon which the wildlife depends; and

WHEREAS, after review of the record and the basis of substantial evidence, the District rebuts any presumption of the adverse effect on fish and wildlife resources of the habitat upon which the wildlife depends; and

WHEREAS, the findings of the 2014 Initial Study / Mitigated Negative Declaration and the MMRP have not changed and the mitigations specified therein still apply with the approval of this addendum; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the Arvin Community Services District as follows:

1. The foregoing recitals are true and correct.
2. The Addendum to the Mitigated Negative Declaration in the form attached hereto is adopted and the addendum is approved.
3. The District's staff and consultants are authorized and directed to file a Notice of Determination in the manner prescribed by the California Environmental Quality Act.
